

**New Home Owners’ Senoko Energy & Citibank Promotion Terms & Conditions
– CITINHOLUV145 promo code**

1. The Promotion commences on 4 Jul to 30 Sep 2023, both dates inclusive (“Promotion Period”).
2. Only Citi Credit Cardholders (excluding Corporate/Commercial Cards) who **sign up or renew for a residential electricity price plan** with Senoko Energy (“Senoko Energy Plan”) online, during the Promotion Period are eligible to participate in this Promotion (“Eligible Cardholder”).
3. Under the Promotion, Eligible Cardholder will receive the below bill rebates (the “Gift”) if he/she fulfills all the following, during the Promotion Period:
 - a. is among the **first 300** customers to sign up or renew online for a **24-month Price Plan** with Senoko Energy;
 - b. inputs promo code during the online sign-up or renewal process;

- c. charges to his/her Citi Credit Card the full amount of their Senoko electricity bill; and
- d. successfully sets up a recurring payment arrangement during sign up/ renewal process and by the relevant stipulated dates in Table 1 below

4. Each Eligible Cardholder is entitled to receive only a one-time bill rebate for a single Senoko Energy electricity account for the contractual period of the Senoko Energy plan that is signed up online.
5. The Gift will be credited by Senoko Energy and used to offset the Eligible Cardholder’s Senoko Energy electricity bill (“Electricity Bill”). If the Electricity Bill amounts to less than the value of the Gift, the remaining value will be used to offset the subsequent Electricity Bill(s).

6. The Gift given under this Promotion is not redeemable or exchangeable for cash or any other payment form and cannot be used in conjunction with other promotional programmes, offers, discount cards, vouchers or VIP privileges, unless otherwise stated.
7. The Gift shall be credited to the Eligible Cardholder's Senoko Energy electricity account by the relevant stipulated dates in Table 1. An Eligible Cardholder who refunds, cancels or disputes the recurring bill arrangement and Senoko Energy Plan before he/she receives the Gift will forfeit the Gift.
8. The Gift credited under this Promotion (i) cannot be used to offset against any minimum payment due under the Citi credit card account and (ii) cannot be withdrawn from the Citi credit card account in cash.
