

Eligibility

1. The Trust Bank Partnership Programme ("Promotion") is available from **23 Jan 2025 to 6 Apr 2025** (both dates inclusive) ("Promotion Period").
2. The Promotion is open to the **first 680 customers** who are new or renewal customers of Senoko Energy Supply Pte Ltd ("Senoko Energy") (collectively, "Eligible Senoko Customers") and principal cardholders of Trust Bank Cards ("Cards") issued by Trust Bank (Singapore) Limited ("Bank") (collectively, "Eligible Cardholders").
3. By participating in the Promotion, the customers agree to be bound by these terms and conditions.
