

Eligibility

1. The Trust Bank Partnership Programme ("Promotion") is available from **8 Jul 2025 to 7 Oct 2025** (both dates inclusive) ("Promotion Period").
2. The Promotion is open to the **first 800 customers** who are new or renewal customers of Senoko Energy Supply Pte Ltd ("Senoko Energy") (collectively, "Eligible Senoko Customers") and principal cardholders of Trust Bank Cards ("Cards") issued by Trust Bank (Singapore) Limited ("Bank") (collectively, "Eligible Cardholders").
3. By participating in the Promotion, the customers agree to be bound by these terms and conditions.

Promotion Mechanics

4. Under this promotion, an Eligible Senoko Energy customer can get a **one-time bill rebate of \$120** ("Rebate") if he/ she renews or signs up via self-help online channels for a twenty-four (**24**) months Senoko Energy residential electricity price plan ("Senoko Energy Plan") if he/she fulfils the following:
 - a) Within the eligible sign-up period, be the **first 800 customers** to renew or sign-up via self-help online channels and input the promo code "**TBKK120**" ("Promo Code") during the sign-up process and
 - b) successfully make three consecutive bill payments using Trust Bank card
 - c) Senoko Energy will award the Rebate to the Eligible Senoko Customers' bill as follow:
 - i. For sign-up period: **8 Jul – 31 Jul 2025**, the rebate will be credited latest by **Feb 2026**
 - ii. For sign-up period: **1 Aug – 31 Aug 2025**, the rebate will be credited latest by **Mar 2026**
 - iii. For sign-up period: **1 Sep – 7 Oct 2025**, the rebate will be credited latest by **Apr 2026**
5. For the avoidance of doubt, this promotion is not applicable to existing Senoko Energy customers with service contracts that are auto-renewed.
6. An Eligible Senoko Customer and Eligible Cardholder will receive a **one-time bill rebate of S\$120** by the third Senoko Energy bill from the new or renewed contract date.
7. Eligible Cardholders whose Card accounts have been suspended, cancelled and/or terminated for any reason during the period of **8 Jul 2025 to 30 Apr 2026** (inclusive of both dates) are not eligible for the Promotion.
8. The one-time Rebate can only be used against payments for electricity charges on the Eligible Cardholder's Senoko Energy electricity account and is strictly non-transferable and non-exchangeable (for cash or credit or otherwise). In the event the Eligible Cardholder's bill with Senoko Energy is lower than the Rebate amount, the balance Rebate shall be carried forward and applied to subsequent bills until all the Rebate has been utilised.
9. In the event of early termination of Senoko Energy Plan by customer of Senoko Energy, no portion of any payments of any kind whatsoever previously provided to customer (including but not limited to rebates) shall be owed or be repayable to customer. For the avoidance of doubt, no portion of any payments of any kind whatsoever previously provided to Senoko Energy shall be owed or be repayable to the Bank.
10. Trust Bank and/or Senoko Energy reserve the right to disqualify, claw back the full or partial Rebate should any of the following situation occurs:
 - a) if the Eligible Cardholder refunds or cancels the 24-month Senoko Energy Plan, he/she will not qualify for the Rebate.
 - b) if the Eligible Cardholder request for early termination of contract, rebate may be revoked.
 - c) if there are any amount of the Rebate be unutilised by the Eligible Cardholder upon termination or expiry of the Senoko Energy Plan.
11. Standard terms and conditions of Senoko Energy and product terms governing the electricity price plan apply.

By using the Promo Code to participate in this Promotion, you agree to be bound by the Terms and Conditions and any amendment we make to these Terms and Conditions and acknowledge that your personal data and/or information will be shared by Senoko Energy with the Bank for the purpose of administering this Promotion.
