

Senoko Energy 2025 - Xiaomi Robot Vacuum S20 (White) EU Promotion Terms & Conditions

1. These terms and conditions shall apply to the promotional code (“Promo Code”) **“GIROSYE5RV”** provisioned by Senoko Energy Supply Pte Ltd.
2. The Promotion Period is from **8 Oct 2025 to 7 Jan 2026**, inclusive of both dates, or while stocks last.
3. The Promo Code is applicable to **New Sign-Ups of Senoko Energy’s 36-month fixed rate, discount-off tariff and discount plans.**
4. The Promotion is limited to one redemption per customer and not applicable in conjunction with other promotions, unless otherwise stated.
5. For the avoidance of doubt, this promotion is not applicable to existing Senoko Energy renewal customers and customers with service contracts that are auto-renewed.
6. Under this promotion, an eligible Senoko Energy customer can get a **complimentary Xiaomi Robot Vacuum S20 (White) EU worth \$359 (“Gift”)** if he/she fulfils all the following:
 - a. Be among the **first 150 customers** to sign up via self-help online channels for a **thirty-six (36) months** Senoko Energy residential electricity price plan (“Senoko Energy Plan”) within the Promotion Period
 - b. Apply the Promo Code **“GIROSYE5RV”** at checkout page, prior to completing the new sign up process
 - c. Successfully sets up **recurring payment for the Senoko Energy Plan via GIRO** by the relevant stipulated dates in Table 1 below
 - d. **Retain the GIRO recurring payment arrangement** for the entire contractual period, or up to the next renewal with Senoko Energy, whichever is applicable.

7. Eligible customers who meet the above requirements will receive a redemption email within 30 working days from their third (3rd) billing, based on the start date of their new Senoko Energy contract.
8. The Gift must be redeemed within one month from the redemption email date. Any unredeemed Gift will be forfeited and no correspondence or claims will be entertained in the event of such forfeiture. A customer whose Gift has been forfeited shall not be entitled to any payment or compensation whatsoever from Senoko Energy.

9. If a customer is unable to redeem the Gift in person, an authorization letter must be presented at the redemption centre managed by Short-Q Private Limited. Some personal data provided by the customer will be disclosed to Short-Q Private Limited, for the sole purpose of administering the Gift.
10. Customers must complete the full contractual period to be eligible for the Gift. Early termination of the contract may result in the Gift being revoked.
11. The Gift is strictly non-exchangeable, non-refundable, and non-redeemable for cash or credit or otherwise.
