



**Terms & Conditions for Samsonite Red - TOIIS C Spinner 20" Luggage and Dreame Hair Glem Hair Dryer Online Exclusive GIRO Promotion**

1. These terms and conditions shall apply to the promotional code ("Promo Code") "**OEGIROSD**" provisioned by Senoko Energy Supply Pte Ltd.
2. The Promotion Period is from **28 Apr 2026 to 30 Jun 2026**, inclusive of both dates, or while stocks last.
3. This Promo Code is applicable to **self-service online sign-ups or renewals for Senoko Energy's 36-month fixed rate, discount-off tariff or discount plans**. For the avoidance of doubt, this promotion is not applicable to:
  - a. existing Senoko Energy customers whose electricity contracts are auto renewed; or
  - b. new Senoko Energy customers who sign up via on-ground roadshow agents
4. Promo Code cannot be applied to previous residential sign-ups except for Senoko Energy customers who are able to renew his/her contract. In such a case, the Promo Code will be applied on the renewal contract.
5. The Promotion is limited to one redemption per customer and not applicable in conjunction with other promotions, unless otherwise stated.
6. Under this promotion, an eligible Senoko Energy customer can get a **complimentary Samsonite Red - TOIIS C Spinner 20" Luggage worth \$320 and Dreame Hair Glem Hair Dryer worth \$299 ("Gift")** if he/she fulfils all the following:
  - a. Be among the **first 140 customers** to sign up or renew via self-help online channels for a **thirty-six (36) months** Senoko Energy residential electricity price plan ("Senoko Energy Plan") within the Promotion Period
  - b. Apply the Promo Code "**OEGIROSD**" at checkout page, prior to completing the new sign up or renewal process
  - c. Successfully sets up **GIRO recurring payment for the Senoko Energy Plan** by the relevant stipulated dates in Table 1 below
  - d. **Retain the GIRO recurring payment arrangement** for the entire contractual period, or up to the next renewal with Senoko Energy, whichever is applicable.

7. The Samsonite Red - TOIIS C Spinner 20" Luggage is available in two colors (Slate Green or Ink Black), subject to the availability of stocks and to be redeemed on a 'first-come, first-served' and while stocks last basis.
8. The Dreame Hair Gleam Hair Dryer is available in three colours (Pink, Blue and Purple), subject to the availability of stocks and to be redeemed on a 'first-come, first-served' and while stocks last basis.
9. An eligible Senoko Energy customer who has fulfilled the requirements above shall receive a gift redemption email, which will be sent within thirty (30) working days after the issuance of their third (3rd) bill from the new or renewed contract start date
10. The Gift must be redeemed within one month from the gift redemption email date. Failing which, the Gift shall be forfeited with no entitlement to payment, refund or compensation from Senoko Energy. For the avoidance of doubt, such forfeiture shall not constitute grounds for the customer to unilaterally terminate or rescind the electricity supply contract with Senoko Energy.
11. Customers are responsible for checking their email inboxes, including junk and spam folders for the redemption email. In some cases, emails may be filtered or redirected by the customer's email service provider. Additionally, if an eligible customer made changes to the email address tagged to their Senoko Energy account, adjusted settings that block emails from Senoko Energy, or unsubscribed from marketing communications, the redemption email may not be received. Senoko Energy shall not be held responsible for any issues arising from unsuccessful email delivery.
12. If a customer is unable to redeem the Gift in person, an authorization letter must be presented at the redemption centre managed by Short-Q Private Limited. Some personal data provided by the customer will be disclosed to Short-Q Private Limited, for the sole purpose of administering the Gift.
13. Customers must complete the full contractual period to be eligible for the Gift. Early termination of the contract may result in the Gift being revoked.
14. The Gift is strictly non-exchangeable, non-refundable, and non-redeemable for cash or credit or otherwise.
