



LifeSavvy24 PRISM+ Q65 Ultra Google TV Lucky Draw 2024

Terms and Conditions

1. These terms and conditions ("Terms and Conditions") shall apply to the "LifeSavvy24 PRISM+ Q65 Ultra Google TV Lucky Draw 2024" ("Lucky Draw") organised by Senoko Energy Supply Pte Ltd (the "Organiser").
2. By registering or taking part in this Lucky Draw, you agree to be bound by these Lucky Draw Terms and Conditions and the decisions of the Organiser in relation to and in connection with this Lucky Draw.

Participation Period

3. The participating period is from 8 May 2024 to 4 July 2024, both days inclusive, or otherwise modified.

Eligibility
