



## Senoko Energy “Watch MasterChef Singapore & Win Weekly Prizes” 2021 Lucky Draw Terms and Conditions

1. This contest (the “Contest”) is organised by Senoko Energy Supply Pte Ltd (the “Organiser”).
2. The Contest is only open to all participants above the age of 18 years with a permanent residential address in Singapore. (i.e. question is revealed each Sunday, and entries need to be submitted by the coming Wednesday) to qualify being entered into the weekly draw for that particular week.
