



Senoko Energy “Empowering Home Chefs” Promotion Terms and Conditions

1. This promotion (the “Promotion”) is organised by Senoko Energy Supply Pte Ltd (the “Organiser”).
2. The Promotion is only open to all persons above the age of 18 years with a permanent residential address in Singapore. Submitting an entry automatically means you are agreeing to abide by these terms and conditions. No third-party entries, bulk entries or entries submitted by agents will be accepted.
3. The Promotion period is from 12 March 2021 till 31 May 2021, both days inclusive, and is limited to the first 100 qualified participants. Any submissions after the cut-off period will not be considered.
4. To qualify for the promotion, the following conditions must be fulfilled:
 - i. You must own a small-scale home-based Food & Beverage (“F&B”) business in a Private and/or HDB Residential Premise. Your flat cannot be registered as a business address.
 - ii. Your home-based F&B business must have been operational in at least the past 3 months from the start of the Promotion period (12 March 2021).
 - iii. You can provide proof that you run a home-based F&B business by, but not limited to, providing the social account handle (Facebook/Instagram) of your business.
5. To participate, you must send the Organiser (@senokoenergy) a private message using your business' social handle on Facebook or Instagram.
6. Upon receiving a confirmation reply from the Organiser via email address, a phone call, or private message on social media, participants can proceed to sign up for or renew any standard residential electricity price plan with a 12-months minimum duration on the Organiser’s website.

7. A SGD\$300 bill rebate will be credited into the participant's Senoko Energy electricity account by the 6th month of when your account is activated and moved in to Senoko Energy.

The Organiser reserves the right to remove or reject, in its sole and absolute discretion, any entry deemed offensive, inappropriate, violative of law, unsuitable in any other manner or that does not comply with the Promotion Terms and Conditions. The Organiser is not required to provide any explanation for the rejection.
9. Each participant is limited to 1 submission in accordance with their residential address and business. Every new sign-up with a unique residential address counts as 1 participation in the Promotion. Submissions will be disqualified if profiles are determined to be fake accounts or spambots, and the Organiser reserves the right to crawl back the rebates accordingly. Submissions must be completed by the deadline stated in the terms and conditions outlined here, with all time stated is in **Singapore Time, UTC +08:00**. The Organiser reserves the right to amend the deadline at any time without prior notice. All submissions received thereafter will automatically be disqualified. Proof of submission is not considered proof of delivery to or receipt of such entry. Furthermore, the Organiser shall have no liability for any submission that is lost, intercepted or not received by the Organiser.
