

Terms & Conditions for Senoko Energy's July-August 2020 "Seafood Dinner" Referral Contest

Terms and Conditions

1. These terms and conditions ("Terms and Conditions") shall apply to the July – August 2020 "Seafood Dinner" Referral Contest ("Contest") organised by Senoko Energy Supply Pte Ltd.
2. By registering or taking part in this Contest, you agree to be bound by these Contest Terms and Conditions and the [legal and privacy policy](#) of Senoko Energy, as well as decisions in relation to and in connection with this Contest.

Qualifying Period

3. Contest period is from 1 July – 16 August 2020, both days inclusive, or otherwise modified. Any referrals after the cut-off period will not be considered. The draw will take place by 31 August 2020.

Senoko Energy reserves the right to suspend, cancel or amend the Contest (including but not limited to replacing the price with one or more items of similar value) and/or review and revise these terms and conditions at any time without giving prior notice. By continuing to take part in the Contest subsequent to any revision of these terms and conditions, each participant shall be deemed to have agreed to any such new or amended terms.

Eligibility

5. Participants must be an existing customer (the "Referrer") and have an existing residential electricity plan with a valid referral code.
6. Participants need to share their referral code and refer a new friend (the "Recipient") to sign up for any Senoko Energy residential electricity account to qualify for the contest. The Recipient needs to key in the Referrer's referral code during point of sign-up in order to qualify the Referrer for an entry in the Contest.
7. Referral recipient's account must be activated and moved into Senoko Energy by 31 August 2020. Each successful referral will count as one (1) chance in the Contest.
